- Deposits are non-refundable (except in the event of a course cancellation), and cover administration costs.
- Applicants will be advised of the date on which the balance of the fee becomes due. After this date, the RSCM reserves the right to re-allocate any places for which the fee has not been paid in full.
- In the event of cancellation by the applicant, a refund will be allowed as follows:
  - Notification received up to 12 weeks before start of course - 80% of full course fee refunded
  - Notification received up to 6 weeks before start of course - 50% of full course fee refunded
  - Notification received less than 2 weeks before start of course - 0% of full course fee refunded
